TERMS AND CONDITIONS

- 2. All horses must be <u>paid for within a 24-hour period</u>, unless other arrangements have been made for payment with the approval of the HVHS management (refer to registration of buyers and authorization).

Terms of Payment:

- <u>CREDIT CARD with a 4 % processing fee added</u> (verification due at registration)
- <u>BANK WIRING</u>: Buyer provides a letter from their bank that verifies funding available, and payment must be sent on the next business day after the sale. (Pre-Arranged with HVHS Staff) Must be made before end of day on Friday prior to sale. (435-503-1320 cell)
- <u>CASH OR CASHIERS CHECK</u>: Check must be made to Heber Valley Horse Sale and delivered to the: <u>154 South 100 West, P.O. Box 285, Midway, Utah</u> <u>84049</u> or sent Overnight- Registered Certified Mail to the above address.
- BANKABLE CHECK: (verification with driver's license) NO OUT OF STATE CHECKS ACCEPTED WITHOUT A BANK LETTER. Make checks payable to Ken Beck and Associates.
- 3. A buyer's number will be issued when you have registered at the sale. For online registration a credit card number is required upon registering. Anything charged to that buyer number is your responsibility. The seller understands and assumes all responsibility for any bid that is made and not honored. If any bid is not honored, the seller agrees to hold HVHS, Inc., staff, and associates harmless.
- 4. When the horse is purchased, buyer assumes responsibility for arranging for the care of this animal until transportation is arranged. Please be reminded that title passes at the fall of the hammer, at which time the purchaser assumes all risk and responsibility to move the horses after the sale. No delivery of the animal will be made until it has been paid for in full. Buyer is responsible for paying transport fees, registration fees (when applicable), and any veterinarian fees that buyer wants to have done over and above what the seller has already made.

- 6. The seller reserves the right to bid on their own horse and can accept or reject the bidding on their animal. A NO SALE must be declared before leaving the sale ring.
- 7. SOUNDNESS GUARANTEE: Every horse consigned to this sale must have a 3-day guarantee for soundness when it is ridden through the ring and sold as a riding horse. The horse must not crib, must hit the ground on all fours properly, have sight in both eyes, and not have a breathing disorder or questionable problems related to these. Please stall your horse for this period and do not put it into a pasture with other horses. If it gets injured after the sale, the soundness guarantee is void. - 8. HVHS DOES NOT GUARANTEE RIDEABILITY. Any guarantee as to the rideability of the horse is strictly between the seller and the buyer. HVHS is released from any responsibility to such guarantees by the seller and buyer. HVHS acts as a selling agent only for the consignors but assumes no liability for either buyer or seller.
- 9. Every effort has been made to ensure the correctness of the online and the printed catalog. HVHS is not responsible for errors or omissions.
- 10. Seller will provide a Brand inspection, a Coggins Test, and a Health certificate, as well as Registration Papers and transfer (where applicable), and veterinary papers (if provided).
- 11. Payment to the seller will be made after 14 days of the sale.
- 12. HVHS will not be held liable for accidents or injury to persons or animals. Any person attending does so at his/her own risk.
